

Artwork Expression of Interest

The City of Ballarat acknowledges the Traditional Owners of the lands we live and work on, the Wadawurrung People and to the North of the municipality the Dja Dja Wurrung Peoples, and recognise their continuing connection to the land and waterways. We pay our respects to their Elders past and present and extend this to all Aboriginal and Torres **Strait Islander Peoples.**









The City of Ballarat invites Aboriginal and Torres Strait Islander artists to submit an Expression of Interest (EOI) to provide a digital design pattern that will be permanently displayed at the Ballarat Aquatic & Lifestyle Centre (BALC). It is intended that parts of this artwork will be incorporated into updated BALC branding.

The Context

BALC stands on the Traditional Lands of the Wadawurrung People. BALC is a busy aquatic and leisure centre, with more than 650,000 visits annually. Facilities include 50m pool, 25m pool, multipurpose pool, Health Club, gymnastics hall and state-of-the-art group fitness studios. The centre regularly hosts regional, state and national swimming and water sport events.

Artwork Opportunity

BALC is looking for an original design by an Aboriginal and Torres Strait Islander artist that reflects our commitment to an inclusive community that supports visitors to connect with, and celebrate, a sense of place.

One part of the artwork must include the perridak (platypus). It is intended that this symbol will be used as part of a future BALC rebrand.

Other themes that may be explored include local seasons, the biodiversity of the area and Indigenous perspectives on the local area.

The final design will be produced as decals for placement on our windows (see Appendix 2).

Location

Please see the appendices to view areas of our facility where the graphic pattern may be used.

Integration of Artwork for BALC

The artwork may be used (in full or part) for other projects relating but not limited to signage, marketing, merchandise, documentation, and uniforms, subject to the licensing agreement.

Licensing

The City of Ballarat will hold exclusive rights for licencing and sole usage of the artwork for 10 years. An Artwork and Commission License Agreement will be provided by the City of Ballarat. A comprehensive artist agreement will be negotiated and signed between both parties. At the completion of the 10-year licencing period, City of Ballarat may seek to renew the licence or commission new artwork

Fees and Charges

Shortlisted artists will be paid a concept development fee of \$500.

The successful commissioned artist will be paid \$5000 including GST*. The fee for the artwork will cover:

- the design and digital production of the agreed artwork
- use of the artist's supplied biography
- use of the artist's supplied explanation or story outlining how the artwork represents aspects of Wadawurrung culture and relevance to this site
- an initial briefing and final meeting to discuss how to extract key elements from the artwork to maintain their meaning
- all future use and publication (in full or in extract) of the artwork
- media opportunities

(*Budget guided by the <u>NAVA</u> Payment Standards for Public Art)

PROJECT TIMELINE

Stage 1: Expression of Interest

Artists are invited to submit an Expression of Interest that briefly outlines artistic approach with examples of artwork to support this. Artists are *not* expected to supply creative concepts or concept artwork as part of this stage. Our selection panel will review EOIs and shortlist up to three (3) artists to progress to stage 2.

Stage 2: Request for Quote

Shortlisted artists are invited to develop their concept and submit concept artwork. A selection panel will evaluate the eligible concepts and consult with experts to select one artist to commission.

Stage 3: Design Development

The successful artist will be required to develop their concept and prepare detailed design documentation for approval by the selection panel.

Stage 4: Delivery

The final artwork must be delivered in a high-resolution (minimum 300 dpi) digital format. All aspects of the installation of the artwork will be completed by the City of Ballarat.
